In general, construction defects are covered for one year after the warranty date — the date title passed to the first new home owner. (General Business Law § 777-a (a)). Plumbing, electrical, heating, cooling, and ventilation systems are covered for two years after the warranty date. (General Business Law § 777-a (b)).

The New Home Warranty and Builders’ Registration Act (NJSA 46:3B-1et seq) was enacted in 1977 to provide a broad scope for the warranty of a new home and standards for construction and quality of the structural elements and components of a new home. Basically, the law requires a builder to register with the State of New Jersey before starting construction of any new home and before offering a warranty on any new home bought and sold in the State.
